## American National Standard

Approval of an American National Standard requires verification by ANSI that the requirements for due process, consensus, and other criteria for approval have been met by the standards developer. #### **Foreword**

- This 3-A Sanitary Standard establishes minimum sanitary (hygienic) requirements for design, materials, fabrication, and/or installation of equipment and/or system(s).
- This 3-A Sanitary Standard is for use on a voluntary basis by directly and materially affected organizations such as equipment and machinery fabricators, processors, and regulatory agencies, and by other SDOs to assure that adequate public health protections exist for the equipment or systems and covered products. 3-A SSI uses this document as its primary source of sanitary criteria for 3-A Symbol authorization and certification.
- This 3-A Sanitary Standard was developed jointly by 3-A SSI, the United States Public Health Service (USPHS) / United States Food and Drug Administration (USFDA), the United States Department of Agriculture (USDA), and the European Hygienic Engineering & Design Group (EHEDG).

#### A SCOPE

- A1 This 3-A Sanitary Standard defines the general requirements for sanitary (hygienic) equipment intended for processing milk, milk products, foods, food ingredients, beverages, or other edible materials.
- A2 To conform to this 3-A Sanitary Standard, equipment shall meet the following criteria for design, material of construction, fabrication techniques, and installation, as applicable. In addition, equipment shall meet the criteria defined in the corresponding 3-A Sanitary Standard for the specific equipment type.
- A3 Specific additional requirements and exceptions to the general requirements contained herein are defined in the individual 3-A Sanitary Standards and 3-A Accepted Practices, listed in Sections A3.1 and A3.2.

#### A3.1 **3-A Sanitary Standards**

Note: New 3-A Sanitary Standards shall be considered to be included in this section 45 days after they have been accepted by the Consensus Body without revision of this General Standard.
