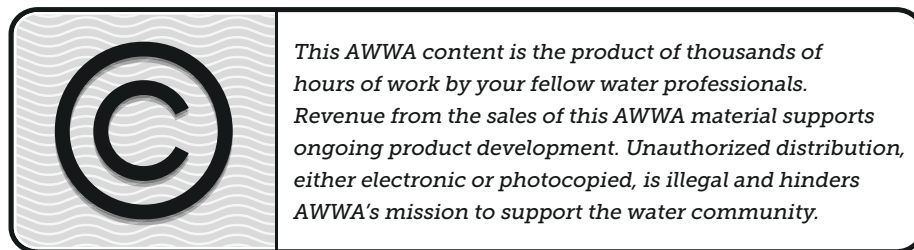
AWWA Standard
