Consequently **JIS G 4053:2008** is replaced with this Standard.

However, **JIS G 4053:2008** may be applied in the **JIS** mark certification based on the relevant provisions of Article 19 Clause 1, etc. of the Industrial Standardization Law until November 20, 2017.
